PERMIT APPLICATION INSTRUCTIONS

APPLICATION FOR PERMIT TO TRANSPORT PASSENGERS FOR HIRE WITHIN THE CITY OF HOT SPRINGS, ARKANSAS

Please read these instructions and Article Two of the Hot Springs Transportation Code before completing the application form.

1. NAME, AGE AND ADDRESS OF APPLICANT(S). Applicant must state his/her name, age and address. If the applicant is a corporation, then list the name, age and address of each stockholder if there are five (5) or fewer total stockholders; or the name, address and age of the registered agent and principal officers if there are more than five stockholders. If the applicant is a partnership or unincorporated association, then list the name, age and address of the managing agent upon whom "service of process" for the partnership or association may be made and the name, age and address of all partners or members.
2. TRADE NAME. Applicant must state the trade or company name under which the permit will be operated. Also, in the case of a corporation, attach evidence of the corporation's good standing with the Office of the Arkansas Secretary of State.
3. PLACE OF BUSINESS. Applicant must state the address of the firm's principal place of business, depot or terminal. In the case of an application for a taxicab permit, this must include the location and telephone number of the dispatch office.
4. PERMIT TYPE. Applicant must check the type of permit being sought.
5. NUMBER OF VEHICLES. Applicant must indicate the maximum number of vehicles to be operated pursuant to the permit if granted.
6. CRIMINAL RECORD. Applicant must provide a statement as to whether applicant, its managing agent or any partner or member of a partnership or unincorporated association applicant has ever been convicted of violating any criminal or quasicriminal statute or ordinance including traffic laws and, if so, the date and place of conviction, the nature of the offense and the penalty imposed. Attach additional pages if necessary.
7. JUDGEMENT RECORD. Applicant must provide a statement as to whether applicant, its managing agent or any partner or member of a partnership or unincorporated association applicant is subject to any outstanding judgement resulting from operation of a motor vehicle and, if so, the court, case number, date of judgement and name and address of judgement creditor. Attach additional pages if necessary.
8. PREVIOUS EXPERIENCE. Applicant must provide a brief but concise explanation of the applicant's previous experience in transportation of passengers for hire including any government which has authorized applicant to operate motor vehicles for hire, whether such authority has ever been suspended or revoked, whether a request for issuance of such authority has ever been denied and the reason for such suspension, revocation or denial.
9. OTHER INFORMATION. Applicant should explain why he/she believes a permit should be issued. Additional pages and/or exhibits should be attached and referenced in this space.
10. REFERENCES. Applicants should provide evidence of his/her good character and business and financial responsibility. Letters of reference, business financial reports, etc., may be attached as exhibits.
11. LOGO DESIGN. Applicant must attach a full color sketch or picture showing the identifying insignia and color scheme of vehicles to be operated by applicant.
12. CERTIFICATION. All parties to the application must sign, date and notarize the certification.
13. APPLICATION FEE. The application must be submitted to the Office of the City Clerk, Municipal Building, Hot Springs, Arkansas, and must be accompanied by a non-refundable application fee of Fifty Dollars (\$50.00).
