**Crime Victims Rights
 Act 1262 of 1997**

As a victim of crime you have the right to:

- Be present at any proceeding where the defendant has the right to be present, unless the court determines it will jeopardize the defendant's right to a fair trial.
- Be informed of services; notified of criminal events in the criminal justice system; notified of any pre-trial or post-trial release of the defendant; and information on appeals or post-conviction remedies.
- Submit victim impact statements during sentencing proceedings and at parole hearings.
- Basic privacy. A victim's address and phone number are exempt from Freedom of Information Act and law enforcement is prohibited from disclosing identity of victim in sexual crimes except under certain conditions.

The Arkansas VINE Program is a free automated hotline that provides crime victims with vital information and notification 24 hours a day, 365 days a year. To register with VINE all you need is basic information on the offender such the offender's name. Live operator assistance is available.

As a victim of crime you have the right to:

- Be present at any proceeding where the defendant has the right to be present, unless the court determines it will jeopardize the defendant's right to a fair trial.
- Be informed of services; notified of criminal events in the criminal justice system; notified of any pre-trial or post-trial release of the defendant; and information on appeals or post-conviction remedies.
